



## **THE TROLLEY BARN**

### **PREFERRED CATERERS**

Our Preferred Caterers are highly recommended and are familiar with the building and policies. However, renters may select any licensed and insured caterer. There is a \$1,000 non-refundable catering fee if an off-list caterer is used.

The insured caterer, or insured bartending service must possess an insurance policy including BOTH **Liquor Liability AND General Liability** with not less than \$1,000,000.00 occurrence limits and \$2,000,000.00 aggregate limits. It must also include the naming of "Trolley Barn" as additional insured. A copy of the insurance certificate must be submitted to the *Trolley Barn* at least 30 days prior to the event date. We have this information on file currently, if you have selected one of our preferred caterers.

**A walk through with the TB Executive Director, catering sales person and event planner (or event point person) is REQUIRED at least 30 days prior to your event.**
